

## YAYSL Minutes March 14, 2007

Communities Present: Austintown, Beaver Local, Boardman, Canfield, Champion, Howland, Lakeview, Liberty, Niles, Poland, Springfield, Warren, West Branch, LaBrae, and South Range.

Communities that have no voting privileges: Beaver Local, East Liverpool, South Range, Team Metro, Springfield, Campbell, and LaBrae will regain or acquire voting privileges in March of 2008 if no meetings are missed during the 2007 season, Liberty-voting privileges reinstated June 2007, Niles-voting privileges reinstated October 2007.

U9/U12 Coaching Modules: Please check the states web site, [www.oysan.org](http://www.oysan.org) for dates, location, and times of classes. Remember you must coach this fall season in order to get reimbursed the \$100.00 class fee. You will also need a copy of your license along with the coach license reimbursement form and present to Heather English, Treasurer, in order to receive compensation. You can obtain the coaches reimbursement form by going to [www.yaysl.org](http://www.yaysl.org) and click on forms.

"D" License Course: Will be held at Stephens Park in Niles. The dates are May 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, and the 11<sup>th</sup>, 12<sup>th</sup>, and 13<sup>th</sup>. You must go to the states web site to register. Remember for this class you will be reimburse 1/2 of the course fee, (\$100.00) if you coach in this fall. In order to be reimbursed you must follow the same procedure as stated above for the U9/U12 license. Anyone that already has a "D" license can audit this course for free.

Goal Safety: The following communities must submit a goal safety policy to John Breedlove as soon as possible: Springfield, Hubbard, Salem, and Beaver Local. If you are a new community or changed your communities name you must also submit a new

policy with the correct name.
