Scheduling Software: Chris Latham(West Branch), Mike Arvin(Niles), and Frank Mancini(Canfield) are still in the process of checking out different programs. They will keep us informed at upcoming meetings.

### **NEW BUSINESS:**

Coaches List: All community representatives must submit a list of their coaches along with their home phone, cell phone, e-mail address, and what age division and gender at June's meeting.

Team(s) Declaration: The team declaration form must be submitted at July's meeting along with payment of \$102.00 per team. This form can be located and downloaded at the leagues website, [www.yayssl.org](http://www.yayssl.org).

Host Site Letter: If you wish to host games at your communities fields you must submit a host site letter with all restrictions listed at July's meeting. This letter must also contain what age divisions can use your fields. Please be very specific about your restrictions. If you do not submit a letter at this meeting, your fields will not have games scheduled on them.

Registration: No date has been set for registration.

Fees: The fees due at registration are as follows: \$15.00 per player/coach. If you have a player/coach that is dual rostered that player/coach must pay the \$15.00 twice. You must also have separate player/coach passes and the passes must be marked "P" for primary and "S" for secondary. Please highlight the "P" or "S". Please make checks payable to YAYSL.

Fall Tournament: Poland will be hosting tournaments again this year. Thanks as always. More information will follow as to what other communities will be hosting this tournament.
