

YAYSL MINUTES

October 10, 2007

The meeting was called to order at 7:30 p.m. by John Breedlove, President.

Communities present: Austintown, Boardman, Canfield, Champion, Howland, Lakeview, Liberty, Niles, Poland, Springfield, Warren, and West Branch.

Communities having perfect attendance up to and including October: Austintown, Boardman, Canfield, Howland, Liberty, Poland, and West Branch.

Communities missing one meeting up to and including October: Champion – missed May's meeting. Niles – missed August's meeting. Springfield – missed April's meeting. Warren – missed August's meeting. LaBrae – missed October's meeting. South Range – missed October's meeting. These communities must attend the November's meeting or they will lose their voting privileges for the next season (2008).

Communities missing more than one meeting and have lost voting privileges: Beaver Local – missed the whole season except for the months of March, June and August. Campbell – missed the whole season. Hubbard – missed the whole season. Lakeview – missed July and October. Salem – missed the whole season except for the months of June and July. East Liverpool – missed the whole season except for the months of April and June. Team Metro – missed the whole season except for the months of July and August.

Expenses that will need to be paid will be: trophies for the regular season and the Fall Classic, referee fees for the Fall Classic, host site reimbursements and coaches clinic reimbursements plus miscellaneous expenses. John Breedlove asked for a motion to accept the submission of the treasurer's report. Tom Brenneis(Poland) made a motion to accept the submission of the treasurer's report. Tom O'Neil(Boardman) 2nd this motion. Motion accepted and treasurer's report was approved.

Fall Classic: As of this date there are 71 teams entered. The U12 and below age groups will play at Perkins Park in Warren. The U-13's and U-14's will play at the Poland fields.

Bothwell Tournament: Will be October 19th, 20th, and 21st. Good luck to all teams that entered.

Coaches Clinic Reimbursement: If you completed a coaches class this past spring/summer please go onto the YAYSL's web site and download the coaches reimbursement form. Have this form filled out completely and attach a copy of your license and bring it to the November's meeting. If you do not have the form or copy of license you will not be reimbursed.

New Communities: Scott MacMillan stated that Lordstown and Newton Falls are interested in joining YAYSL next spring/fall.

That should do it for this meeting. Please don't forget to have your Host Site form and Coaches reimbursement forms filled out and bring to November's meeting. Our next regular scheduled meeting is the AGM. This meeting will be at Inner Circle Pizza, 7:30 p.m. on November 14th.
