Risk Management: Every coach, potential coach, trainer, or anyone directly involved in with teams must fill out a Risk Management on-line. This must be done quickly as it can take some time to process your application and you must be approved prior to fall registration, which takes place in July 2009. The form will require a payment code and that code is 57174.

Goal Safety: Every community will be required to have a Goal Safety Policy on file with YAYSL. A template will be e-mailed to all communities who in turn will fill out and e-mail back to the secretary. This must be done as soon as possible. Thanks. All fields and goals will be inspected this year by YAYSL. Please read the Goal Safety Manual that is posted on the YAYSL's website and make sure your community adheres to the requirements.

Field Insurance: All communities who have host fields or practice sites must have those sites listed on the insurance. Please go to the states web site, [www.oysan.org](http://www.oysan.org) and fill out the form listing all your fields, practice sites, etc. This must be done as soon as possible. The state will, after receiving your information will mail a Certificate of Insurance to the owners of the fields, sites, etc.
