

# YAYSL MINUTES

**Goal Safety policy:** A template will be sent to all communities to update. Please send to Mike Arvin when completed. This must be done as soon as possible.

**Stateline League Tournament:** Will be held May 1<sup>st</sup> and 2<sup>nd</sup>. 100 teams maximum. Please contact Scott MacMillan for any information you may need.

**Coaching requirements:** Beginning in fall of 2011, all rostered coaches must have a minimum of a U/9-U/12 coaching license. In order to meet this requirement, the state will decrease the cost of this course. More information will follow at future YAYSL meetings.
